HUNTER PACE SERIES

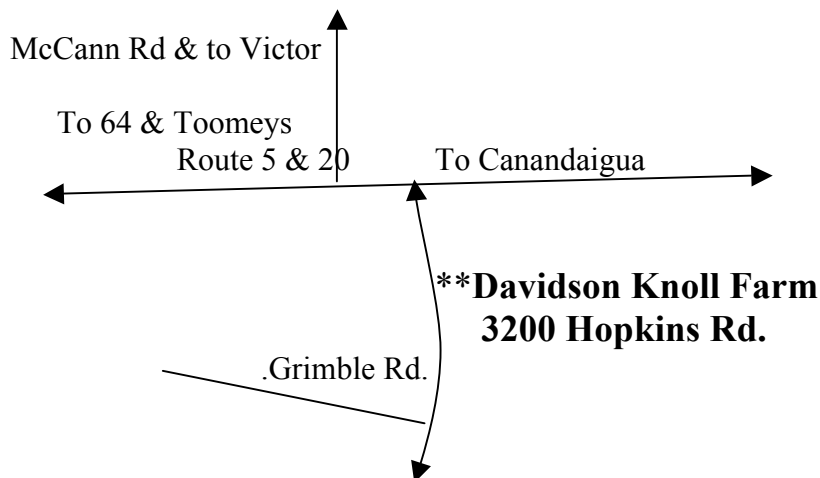
Davidson Knoll Farm will be offering a 2010 summer Hunter Pace Evening Series. Come match the excitement of the fox hunt and ride the beautiful Bristol Hills.

Points will be accumulated on an individual basis for end of the year awards. *Davidson Knoll Farm reserves the right to cancel or add dates for the 2009 series.*

Riders in teams of two (or more if you like) will follow a well-marked course of about 5-6 miles through natural hunt country at an "ideal pace". The winning team is the group whose time on the course is the closest to the "ideal time". Fences a maximum of 2'6" and are optional. Six pairs of ribbons will be presented for closest to optimum time per division.

- Riders must be back in from the course by 7:30 pm on Wednesdays and by 1 pm on Saturday.
- Boots and protective headgear are required. Balance of attire is discretionary.
- All riding disciplines are welcome.
- All entrants must sign a liability release form. If under 18, a parent or guardian must sign release form. Release is located on the bottom of the entry.
- A 2009 or 2010 negative Coggins test is required.
- Juniors under 16 years of age must ride with an adult (over 18 years of age).
- All riders who intend to ride at a leisurely pace come early!
